2017 HIGHLIGHTS

Law Enforcement

Serves youth brought to the Juvenile Assessment Center by law enforcement officers. Staff works to understand the underlying factors driving the delinquent behavior and link youth/families to resources.

1,656 Youth Served

Staff sent over **200** referrals to the Innocence Lost Taskforce due to concerns of child sex trafficking and one referral for child labor trafficking.

The time it took Law Enforcement to drop off a youth and get back on the streets was an average of **5 minutes** and **34 seconds**

The JAC saves Law Enforcement in the 18th Judicial District a total **7,397 hours** or **308 days!**

Community Assessment Program

Serves youth and families on a voluntary basis to better understand the underlying factors contributing to behaviors such as truancy, substance use, disruptive behavior in the home, etc. Licensed clinicians work to identify the most appropriate and accessible resources for the youth and family.

772 youth and families served

98% of youth report a supportive experience at the JAC

80% of parents express hope in their ability to get help

77% of families are engaging in the resources recommended by JAC Staff

Dear JAC Supporters,

I am proud to say 2017 was a year of growth, collaboration and celebration! The Juvenile Assessment Center staff have continued to work hard to get at the root of underlying issues driving concerning behavior. This year we increased the number of youth served from 2,149 youth in 2016 to 2,422 in 2017. This 12.7% increase is primarily occurring in our prevention work as we develop new relationships with schools, municipal courts, partner agencies and businesses. In 2018 and beyond, our focus will continue to be on prevention while strengthening our efforts alongside law enforcement and the judicial system.

As my first year serving as Executive Director passes, I am continually humbled at the passion the JAC staff, Board of Directors and community partners have to ensure we are responding to the issues our youth are facing in a trauma-informed and holistic manner. I am looking forward to what the future holds for the Juvenile Assessment Center and our community!

WHAT'S NEW?!

■ School Responder Model - Integrative School Response to Behavior

The Juvenile Assessment Center was awarded a grant by the Denver Foundation to pilot a “school-responder model” in Sheridan School District. This pilot will look at how a JAC clinician can help school districts identify concerning behaviors early and support families as well as coordinate services for youth prior to higher-level discipline (suspension/expulsion).

■ Handle With Care – A Collaborative Response to Trauma

Handle With Care — The Juvenile Assessment Center in partnership with the school districts and police departments in Sheridan and Englewood launched Handle With Care. Handle with Care is an initiative that encourages law enforcement officers who during a call encounter a child that has experienced trauma (i.e. domestic violence, drug-related, etc.) to immediately send a notice to the school before the next school day. This allows the school to be aware of the fact that a child has recently experienced trauma and steps can be taken to mitigate any further trauma from the school.

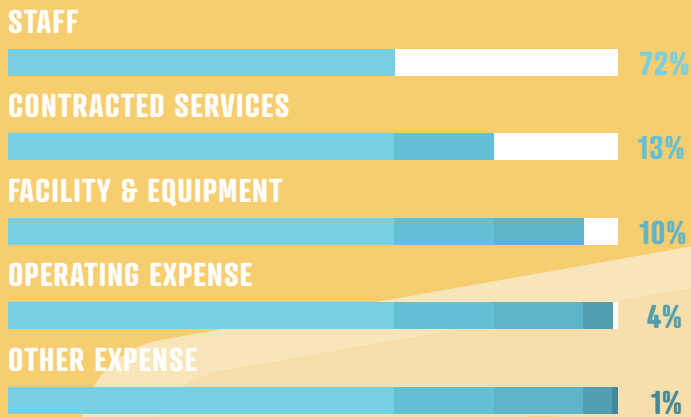
Almost 100 Handle With Care notices were issued in 2017!

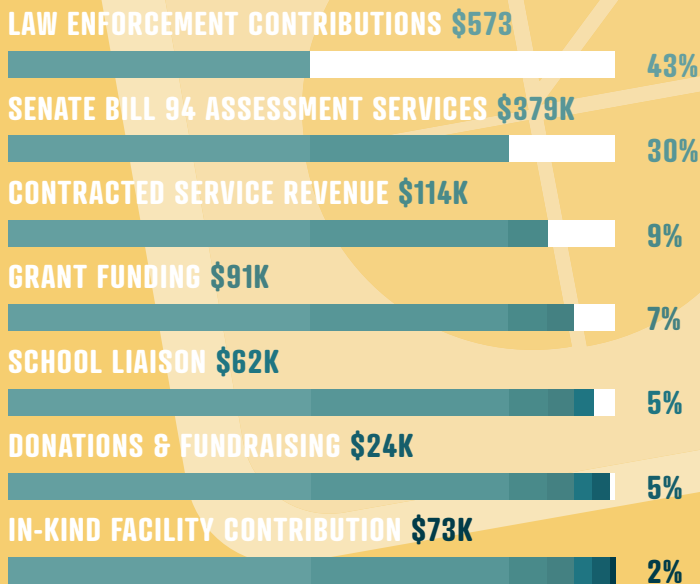

OPERATING EXPENSE BREAKDOWN



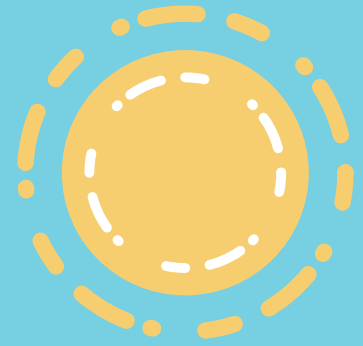
ANNUAL BUDGETED INCOME BY SOURCE
